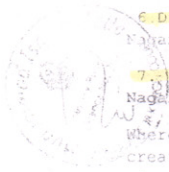
This Supplementary trust deed to the trust deed dated 30-09-2005 is executed on this 21st day of December 2013 at Srinagar by and between;

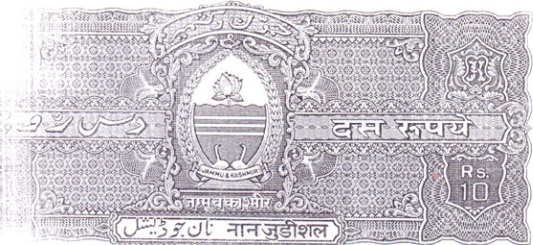

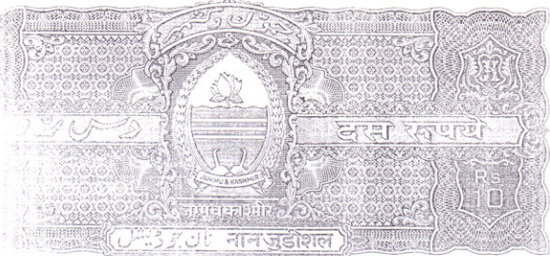
